


NEW YORK CITY STUDENT SAFETY ACT REPORTING 2ND QUARTER 2018, APRIL 1 TO JUNE 30



An analysis of the Student Safety Act data from the second quarter of 2018 shows an increase in total NYPD interventions in New York City schools compared to the same period in 2017 – from 2,620 interventions to 3,060. In both quarters, 38% of all incidents were “mitigated” or referred for school disciplinary procedures rather than being processed as an arrest or summonsed.

- In 2018 there were 433 uses of metal handcuffs during a police intervention, while in 2017 there were 411, an increase of 5%.
- In 2018 there were 33 uses of force reported, while in 2017 there were 21, an increase of 57%.
- The three precincts with the highest numbers of arrests and summonses in this period were the 47th precinct in the northern Bronx with 31 incidents, the 42nd precinct in the Morrisania section of the Bronx with 27 incidents, and the 71st precinct in central Brooklyn with 21 incidents.

School-Based Arrests

- 56.8% of all arrests were carried out by patrol officers, while 21.1% of all arrests were carried out by School Safety Agents and 5.4% were carried out by the Uniformed Task Force of the School Safety Division.
- 39.5% of arrests were charged with Assault (74% of all assaults were misdemeanors), while 11.6% of arrests were charges of robbery
- In 2018, 32.7% of all arrests occurred in response to incidents that happened outside of schools, while in 2017 that number was 23.1%.
- The school campuses with the highest number of arrests were Evander Childs (7) in district 11 in the Bronx, and Humanities & Arts Magnet High School (7) in district 29 in Queens.

School-Based Summonses

- 55.8% of all summonses were distributed by NYPD patrol officers, while 44.2% were carried out by the School Safety Division of the NYPD.
- 30.7% of all summonses were given for possession of marijuana, while 24.2% of summonses were given for disorderly conduct.
- The school campuses with the highest number of summonses were Adlai Stevenson (12) in district 8 in the Bronx, and Evander Childs (8).

School-Based “Child in Crisis” Incidents

As defined by the NYPD, “child in crisis” describes a student who is removed from school to the hospital for psychological evaluation due to perceived emotional distress.

- In 2018, 32% of incidents involved children under 10 years old, two incidents involved four-year-old students; in 2017, 25% of incidents involved children under 10 years old.
- 96 incidents (9%) involved restraints; in 2017, 95 incidents (11%) involved restraints.
- The schools with the highest number of incidents are JM Rapport School for Career Development (15) in district 75 and PS 5 (11) in district 7.
