

The State of America's Children® in CALIFORNIA

2021 Factsheet



Child Population

- **8,894,641** children lived in California in 2019.
- **74 percent** were children of color: 5 percent were Black; 52 percent were Hispanic; 12 percent were Asian/Native Hawaiian/Other Pacific Islander; and <1 percent were American Indian/Alaska Native.

Child Poverty

- **16 percent** of California's children were poor in 2019—a total of **1,363,574** children—and children of color were disproportionately poor.
- **26 percent** of Black, **21 percent** of Hispanic and **7 percent** of white children were poor.
- **6 percent** of children were extremely poor (their family had income below half the poverty level).
- **16 percent** of children under 6 were poor.

Income and Wealth Inequality

- **\$123,500** was the median income for white families with children compared with **\$58,800** for Black and **\$57,600** for Hispanic families in 2019.

Housing and Homelessness

- **263,058** unhoused children were enrolled in public schools during 2017-2018.
- **2.8 full-time jobs** at minimum wage were needed for a family to afford a two-bedroom rental unit at fair market rent in FY2020.

Child Hunger and Nutrition

- **15 percent** of children lived in food-insecure households in 2018.
- **21 percent** of children relied on the Supplemental Nutrition Assistance Program (SNAP) in FY2018.
- **85 percent** of children receiving free or reduced-price lunch during the 2018-2019 school year did not participate in Summer Nutrition Programs in 2019.

Child Health

- **334,034** children ages 0-18 (**4 percent**) were uninsured in 2019.
- **4,874,521** children ages 0-18 were enrolled in Medi-Cal (combined Medicaid and Children's Health Insurance Program) in 2019.

Early Childhood

- **\$17,384** was the average annual cost for an infant in center-based child care in 2019.
- **38 percent** of 4-year-olds were enrolled in state-funded preschool during 2018-2019.

Education

- **82 percent** of Black, **78 percent** of Hispanic and **51 percent** of white 4th grade public school students were not proficient in reading in 2019.
- **90 percent** of Black, **81 percent** of Hispanic and **55 percent** of white 8th grade public school students were not proficient in reading in 2019.
- **73 percent** of Black, **81 percent** of Hispanic and **87 percent** of white students graduated high school on time during 2017-2018.
- **10 percent** of Black, **3 percent** of Hispanic and **3 percent** of white public secondary students had at least one out-of-school suspension in 2015-2016.

Child Welfare

- **64,115** children were abused or neglected in 2019.
- **51,268** children were in foster care on the last day of FY2019.

Youth Justice

- **5,463** children were in residential placement in 2017. **26 percent** were Black; **56 percent** were Hispanic; and **14 percent** were white.
- **0** children were in adult jails or prisons in 2019.

Gun Violence

- **232** children and teens were killed with guns in 2019.
