Dear Chair Crapo, Ranking Member Wyden, Chair Cassidy, and Ranking Member Sanders:

As you re-open the work of the U.S. Senate Health, Education, Labor, and Pensions (HELP) Committee for the 119th Congress, we write to thank you for accepting oversight responsibility for agencies vital to the well-being of American children and families. Last week, in celebration of the Rev. Dr. Martin Luther King, Jr., people of faith across the country re-committed to building the Beloved Community: a place of health, hope, and wholeness where all children are well. With our own sense of call to the work of healing in mind, we write to express our strong opposition to the confirmation of Mr. Robert F. Kennedy, Jr., as Secretary for the United States Department of Health and Human Services (HHS).

We believe healthy, laughing, nourished, dancing, growing, learning, and thriving children are the sign of a strong nation. In Beloved Community, all young people enjoy regular, nourishing meals and active lives, marked by positive social adjustment, sustainable environments, and health care homes for their bodies and minds. We are called to reflect God's healing character by creating the conditions for young people to thrive. In fulfilling this call, we advocate for leaders steadfastly committed to advancing public health. This is especially important for HHS and the role to which Mr. Kennedy Jr. aspires.

The Department is charged "to enhance the health and well-being of all Americans, by providing for effective health and human services and by fostering sound, sustained advances in the sciences underlying medicine, public health, and social services." The Secretary will guide (among other agencies) the Administration for Children and Families, the Centers for Medicare and Medicaid Services, and the Substance Abuse and Mental Health Services Administration (SAMHSA). In this role, Mr. Kennedy Jr. would have unique responsibility for the 37.6 million children enrolled in the Children's Health Insurance (CHIP) and Medicaid programs.

Unfortunately, Robert F. Kennedy, Jr.'s public record militates against the very mission of the Department and places children in jeopardy. The Secretary of Health and Human Services must be guided by a commitment to public health, sound science, and policies that promote wholeness for individuals, families, and communities. Yet, we share the concerns of several members of the HELP Committee and your colleagues in the Senate regarding Mr. Kennedy Jr.'s history of promoting policies based on fringe science and rejection of scientific evidence which has real-world consequences.

In basic guidance to parents and caregivers in our communities, we encourage them to take children (with access) to the doctor for regular check-ups and vaccines, to the dentist for good oral health, and to be consistent with their instruction to ensure young people understand their responsibilities for their own care. The nominee's personal and organizational contributions to anti-vaccine theories have been so vast that a 2023 Indiana University study of public COVID-19 communications pointed to him as "the top superspreader" of health misinformation, accounting for 13 percent of misleading retweets on social media platforms. Mr. Kennedy Jr. complicates basic parenting, science, and health by suggesting an early Administration push to remove fluoride from drinking water, advancing conspiracy theories subverting its documented value to oral and cardiovascular health.

Furthermore, his recent waffling on other health positions related to the country's most critical concerns, raise questions about his intellectual curiosity and principled commitment to assessment of matters for which the Secretary of Health and Human Services must provide steady direction for a nation of 335 million people, especially its more than 73 million children and youth. As the Robert Wood Johnson Foundation, the nation's leading health philanthropy, has noted, Mr. Kennedy Jr.'s reckless public rhetoric on health issues has undermined trust in public health and endangered lives. As his actions have already harmed tens of thousands, we shudder to imagine the consequences of his leadership for the Department.

Our nation deserves a Secretary for the U.S. Department of Health and Human Services who is guided by evidence, demonstrates wisdom, and models commitment to protecting all Americans. This is a matter of public safety, trust, and care where leaders from both sides of aisle agree. Furthermore, there are far more qualified candidates for this critical role.

We urge you to act in the interest of America's health and her children by ending Mr. Kennedy Jr.'s consideration in the HELP Committee, preserving time with your colleagues in the Senate for discussion of a more committed and qualified nominee. In this unique time, let us heed the call to health and healing, by agreeing to live our highest values and care for children and youth. We stand ready to speak with you further regarding our concerns on this matter.
